008.01.01 To consider and approve the request of Dr. K.Ruckmani, Professor and Head,
Department of Pharamaceutical Technology, Bharathidasan Institute of
Technology (BIT) Campus, Tiruchirappalli for providing interdisciplinary
training-based learning for the students of Pharmaceutical Technology to
improve the employability.

K.Ruckmani, Professor and Head, Department of Pharamaceutical Technology, Bharathidasan Institute of Technology (BIT) Campus, Tiruchirappalli had submitted a proposal requesting to give special training to the B.Tech. and M.Tech. students of Pharmaceutical Technology to improve the employability. The Department is having many sophisticated Instruments and hands on experience will help the students in placement. A workshop on interdisciplinary training-based learning to the 122 UG and PG students of Pharmaceutical Technology is proposed at an estimated cost of Rs.5,00,000/- (Rupees Five lakhs only).

The proposal was discussed in the 7th BoG on 13-08-2014 as table agenda. As per the direction of the BoG, Dr. K. Ruckmani has submitted the revised proposal for five days with the financial commitment of Rs.1,75,000/- to improve the technical skills of TWENTY FIVE students for the better employability which is one of the prime vision of Institutional Development Plan (IDP) of Bharathidasan Institute of Technology (BIT) Campus, Tiruchirappalli. The expenditure incurred of Rs.1,75,000/- towards the training of students to be met from the heads of Academic Support for weak students (8) of TEQIP II may be approved.
