**Minutes**

The seventh BOG meeting was conducted in the Dean's meeting Hall. - To encourage students for institution –industry collaboration by under taking research projects.
- To increase the employability of the students by conducting placement training programmes and other soft skills

- To improve the research potential of the faculty by providing some permissible research grants.
- To indentify weaker students and conduct remedial classes.
